

Minimizing Opioid Prescriptions: A New Standard of Care?

As an oral and maxillofacial surgeon, I am keenly aware that many of my surgeries are associated with a defined postoperative period of pain or discomfort. The same can be said for complex dental procedures and periodontal surgeries. Third molar surgeries are performed nearly every day in my practice and across the country both in oral surgery and dental offices. Anecdotally, it seems that opiate pain medications have traditionally been prescribed after dental surgery procedures. In fact, retrospective studies have shown that 95% of patients undergoing third molar surgery received a written opioid prescription (Tompach et al, JOMS 2019). Instituting a post operative pain control protocol has been critical across medical and dental specialties to limit opioid prescribing. I hearken back to my lectures at Penn Dental with renowned dental pharmacologist, Dr. Elliot Hersh. Dr. Hersh emphasized with all of us that a combination of 600mg of ibuprofen combined with acetaminophen in therapeutic doses has been shown to be more effective than an opioid medication for post-surgical third molar pain. At an early point in our training, Dr. Hersh instilled in us the notion of multimodal pain management. For that I am very thankful! Nonetheless, dentists are the second most frequent opioid prescribers after internists (Guy et al. Am J Prev Med. 2018). Multiple

articles have been published by the Journal of the American Medical Association documenting the risk of persistent opiate use in opiatenaive patients after dental surgery (Harbaugh et al, JAMA 2018, Schroeder et al, JAMA 2019).

In 2018, liposomal bupivacaine (LB: trade name EXPAREL) was approved by the FDA. It is approved for local infiltration in adults and children aged 6 and older for postoperative local analgesia. It is also approved for inter scalene brachial plexus nerve block for regional anesthesia. It is not approved for intraoral nerve blocks (inferior alveolar, lingual, PSA). It is approved only for local infiltration in a supraperiosteal (above the periosteum) plane. Functionally, it is a liposomal formulation of bupivacaine. As we all know, bupivacaine is a long acting local anesthetic. When packaged with liposomes, the bupivacaine gets slowly released into the tissue for 72 hours. Local anesthesia is still required when using Exparel because its effects are delayed. We have incorporated LB into our practice and have seen a significant drop in opiate prescriptions. phase 3 double blind randomized, placebo-controlled study showed that LB reduced post surgical pain scores in patients undergoing third molar surgery (Lieblich, INNOVATE study, Anesthesia Prog. 2017).

Overall, my experience with Exparel has been positive, but there are a few downsides that I have seen. The cost of the medication has been a limiting factor for some patients. I would like to see Pacira work towards lowering the drug cost to make it more accessible for patients and practices. Like many drugs, once there is more competition in the market, prices will decrease. There is, however, an increased number of medical insurance companies covering the medication now, which should help offset these costs for patients. There have also been a few local paresthesia incidences reported, but these have all been transient.

I wanted to bring this to our members' attention because this has helped my patients and significantly reduced my opioid prescriptions. Opioid prescriptions for opioidnaive patients are associated with a risk of persistent use (Harbaugh et al, JAMA. 2018). I have seen LB widely used in the hospital, especially in orthopedics and Outside of hospital obstetrics. based administration and third molar surgery, I have not yet seen LB incorporated into dentistry. It may be useful in other aspects of dentistry and I encourage our members to do further reading.

Dr. Bruno Azevedo – Demystifying Cone Beam CT in Dentistry



ABOUT THIS COURSE: Cone-beam computed tomography (CBCT) is an indispensable tool for diagnostic imaging in the dental practice. Understanding the principles behind high-resolution 3D imaging volumes and the differences between the field of views applications in different dental specialties is a must. CBCT imaging of the jaws provides dentists with greater diagnostic accuracy for dental and root morphology and pathology related to teeth and bones than conventional 2D intraoral digital imaging. CBCT imaging also acts as a scaffold for newly developing dynamic navigation and other advanced technologies. The use of the CBCT image provides the clinician with a greater degree of confidence in detecting anatomical variations and pathologies, it acts as a tool to support the clinical decision, as it offers valuable information about when to treat, how to treat and, as important, when not to treat. This lecture will cover the four pillars of imaging principles: Data Acquisition, Data Correction, Data Navigation, and Data Interpretation. Those are essential skills that can improve practice production and optimize radiographic diagnosis and treatment planning sessions. This course will quide clinicians through all the

steps on incorporating CBCT imaging in their daily practice and demystify basic to advanced principles regarding the diagnostic capabilities of 3D imaging.



More on Clinical HYPNOSIS

I like to use this example of a phobia because it demonstrates how illogical phobias can be. This woman was a functional adult, of at least average intelligence, who saw that this snake was not real and did not pose any threat to her. At the same time, some part of her brain was shouting, "Run! A snake!". Although the more analytical, left-brained part of her mind knew she was safe, the more emotional, right-brained part did not.

When a person has a phobia, no amount of rational explanation or factual information will fix it – because the person already knows! The key is to get their "left brain" to teach their "right brain" that the object of fear (the snake, the public speaking, the dental visit) does not pose a danger. That's one of the uses of clinical hypnosis. When a person is in a state of deep absorption, otherwise known as trance, they are more open to that kind of emotional learning. When they return to their more typical level of awareness, the "right brain" has learned that it can feel safe and calm when encountering whatever was previously frightening. A similar process can help with habit change - during the hypnotic state, the "right brain" can learn what the "left brain" already knows, which is that the stress eating, nail biting, smoking, etc., is causing more problems than it is fixing, taking away its emotional appeal.



makes hypnosis so useful in the field of dentistry.

Many of you may know Dr. Alvin Arzt, who in addition to working for many years as a dentist in private practice in Levittown also served as a president of Montgomery Bucks Dental Society and as an Editor of the Bulletin. Dr. Arzt was certified in hypnosis by the American Society of Clinical Hypnosis in 1982. Dr. Arzt used hypnosis in his practice not only to help fearful patients, but also to relieve excessive gagging, decrease bleeding after dental extractions, and provide anesthesia for some dental procedures. Given its safety and effectiveness, he now advocates that "the use of hypnosis should be a part of every dentist's training".

For those who would like to learn more about how to use hypnosis, the American Society of Clinical Hypnosis, or ASCH (asch.net), offers workshops throughout the year. For those who think that their patients might benefit from hypnosis before a planned procedure, I welcome new referrals for patients of all ages. Additional practitioners of clinical hypnosis can also be found on the ASCH website.

Glenn Goodhart 2021 Alumni Achievement Humanitarian Award

Upon graduation from Temple Dental School in 1966, Dr. Glenn Goodhart entered the General Practice Residency at Einstein Medical Center Northern and Southern Divisions, then the Didactic Residency Program in Oral Surgery at the University of Pennsylvania Dental School and graduated in 1968. One week prior to his graduation, Dr. Goodhart's father, Robert R. Goodhart, D.D.S., FAGD '41 and fellow Temple Dental graduate passed away suddenly at the young age of 51 in his professional prime. To keep his father's legacy alive, Dr. Goodhart moonlighted in his Cheltenham home office dental practice for the next two years while he was in residency programs. Shortly after his Didactic Oral Surgery Residency, Dr. Goodhart took over his father's practice and has managed it for more than 50 years and counting.

At Temple Dental, Dr. Goodhart maintains that he was fortunate to have been taught by some of the greatest dental minds of the 20th century. His most influential faculty included D. Walter Cohen, Morton Amsterdam, Leonard Abrams, Arnold Weisgold, Sam Seltzer and the list goes on; however, Dr. Goodhart knows the greatest teacher was his father, Robert R. Goodhart. His philosophy of practice, his innovative mind, his empathy and compassion towards his fellow man, and his commitment to community were the foundation of his practice. Dr. Goodhart says, "All I did was try to follow in his footsteps, as large as they were."

Michael Bydalek 2021 Alumni Achievement Service Award

After graduating from the Temple University Maurice H. Kornberg School of Dentistry in 1989 and having completed a GPR residency, his solo general dentist practice was opened in 1990. In 2000, the practice was moved to its current location, after purchasing a professional corner lot building. Patients still give Dr. Bydalek a "drive by shout out" when they see him doing his own landscaping.

Organized dentistry has played a major role in his growth and development. The lead into organized dentistry started with participation in the Pennsylvania Academy of General Dentistry's PEAK CE program. Relationships formed, leading to many years of involvement with the Academy of General Dentistry (AGD) at both the state and national level from 1994-2008; and with the State PAGD as the Membership Chair, Electronic Media Chair, Secretary/Treasurer and Regional Director, Dr. Bydalek has also served on the National AGD as Communications Chair, Internet Council, Leadership Conference Speaker, and Delegate. In 2011, Dr. Bydalek became involved with leadership roles in the International College of Dentists, national level; as Ad-Hoc Technology Chair, Foundation Trustee, Fellowship Orientation Program Chair, Foundation Treasurer.

Throughout his 30 plus years since graduation, Dr. Bydalek has remained connected with his alma mater, Temple Dental serving as Campaign Ambassador and Reunion Ambassador. He is most proud of his almost decade long, annual, grey haired, "What I've Learned" presentation to the AEGD program at Temple Dental. Dr. Bydalek and his wife, Marilyn, met while both studied for their undergraduate degrees at Temple University (Class of 1984).

When not in the office and or traveling for the ICD, he surfs, plays pickleball and attends Sixers games.

Theodore Croll 2021 Alumni Achievement Education Award

Ted Croll lives in Bucks County, Pennsylvania with his wife, Deborah. He is a 1973 graduate of Temple University School of Dentistry. Dr. Croll served as captain and major in the U.S. Army Dental Corps in Hanau, Germany, from 1973-1976. He then received his pediatric dentistry specialty certificate at University of Connecticut in 1978. He has practiced pediatric dentistry in Doylestown, Pennsylvania. Since then, his practice merged with Doc Bresler's Cavity Busters in 2018.

Academic affiliations over the years include faculty positions at The University of Pennsylvania, University of Texas in Houston, University of Iowa and University of Washington and currently he serves as Adjunctive Clinical Professor, University of Texas in San Antonio and Clinical Professor at Case Western Reserve. Dr. Croll is a Fellow of the American College of Dentists and Fellow of the International College of Dentists. Since 1978, Dr. Croll's contributions to the literature of dentistry include more than 300 peerreviewed articles in national and international dentistry journals. His textbook, Enamel Microabrasion, was published in 1991, and translated into Russian and German by Quintessence Publishing Company. The American Society of Dentistry for Children published Croll's ASDC Kid's Mouth Book in 1999. Willipus Wallipus, a picture book for children about a nose-snatching sea monster, was published in 2006. Dr. Croll collaborated with Dr. Benjamin Spock and Dr. Steven Parker in writing the dentistry sections of the 50th year anniversary edition of Dr. Spock's Baby and Child Care, published in 1998. The third volume in Dr. Croll's "Gross" series, The Grosset, Truly Terrifying, But Utterly Awesome Mouth Book was introduced by Practicon in 2020 with French and Spanish translations in 2021. His clinical writings for dentistry publications and contributions to the Journal of the History of Dentistry are ongoing.
